- Standard plan review time is 8 business days*.
- Plans reviewed in 3 business days for 2x the base plan review fee*.
- Plans reviewed in 1 business day for 3x the base plan review fee*.

*Plans received after noon will be counted for the following business day.

Inspections

- Review plus Inspections includes up to (4) field inspections. Additional inspections will be billed per hour and may include travel time. Large projects will include additional fees to account for additional inspection time spent on the project.
- Fire Savvy requests 48 hours notice for inspections and are subject to schedule availability.
- Additional fees apply for large projects and are based on hourly rates.
- Minimum inspection fee is \$150.00.
